This contract is considered legally binding between Charlottesville Fencing Alliance (hereafter CFA) and _____ . This contract is in effect for the duration of your membership with CFA. CFA provides open fencing and training in the sport of fencing.

Membership:

Membership privileges include the following:

- Use of facility and any loaner gear (limited amount) the club has
- Training in either the beginners, C1, or C2 level classes, depending on skill level
- Supervised open fencing

Membership cost:

- Beginners Class: \$150 for 8 class sessions. Cost covers use of loaner gear. Payment due at first class.
- C1, C2 Classes: \$50 per month. Payment is due by the first class of each month.
- Summer Camp: \$300 for each one week session. Cost covers use of loaner gear. Payment due on first day.

Availability:

CFA is located at 1731 Allied St., Charlottesville, VA 22903. Current schedules are posted on our website, listed above.

Safety Rules:

1. Respect the weapons. Carry them point down when out of a bag and around unmasked members.
2. It is absolutely forbidden for anyone to touch another fencer with a sword unless they are wearing proper fencing kit.
3. We strongly encourage all members to stretch out and warm up before taking lessons or fencing classes.
4. No running permitted in the Salle.
5. A mask, glove, fencing jacket, fencing pants or long pants, and athletic shoes are required.
6. Fencers should all fence in the same direction on the fencing floor.
7. No drugs or alcohol are permitted. Fencers may not participate if they are under the influence of such.
8. Any illness or injury must be brought to the attention of an officer before fencing begins.

Legal Notices: Before you sign please read. This is a legally binding contract.

1. You represent that you are in good physical condition, have no physical or mental health problem that will preclude your participation in fencing activities. Specifically you represent that you have no underlying cardiovascular, neurological or any other illness that will prevent or inhibit your participation in the fencing activities.
2. CFA represents that its officers are trained in the sport of fencing. CFA represents that its officers have no expertise in diagnosing, examining or treating medical conditions of any kind or in determining the effect of specified exercise on said medical condition. You fully understand and agree that in participating in any fencing program there is the possibility of accident, injury, disability or death. You agree to assume these risks and release and discharge the officers, operators, the USFA, and sponsors of the premises, activities, etc. and their respective servants, agents, officers and all other participants in the stated activity of and from all claims, demands, actions, and causes of action of any sort, for injuries sustained to the members person and/or property during the members presence on the premises and the members participation in the stated activities.
3. You give consent to CFA and its representatives to obtain medical care at your expense from any licensed physician, hospital, or clinic for you and or the above-mentioned student for any injury or illness that may arise during activities associated with CFA.
4. You agree to be bound by the CFA equipment, facility, and safety rules.
5. You agree to pay a charge of \$30 for any checks written in payment to CFA that are returned due to insufficient funds.
6. The laws of the Commonwealth of Virginia will govern this contract. If any portion of this contract is held invalid or unenforceable, the remaining portions of the contract shall remain in full force and effect.
